The CCW Board of Directors meeting, with President Sheila Bowen presiding, was held June 12, 2015, at the Double Tree by Hilton in Sacramento. Past presidents attending were Judy Ahmann, Karen Sweet and Jean Barton. Past President Gretchen Johnson was remembered with a moment of silence. There were 74 members and guests present.

Treasurer Melody Lake reviewed the financial report. She asked that when checks are sent to her, let her know what it is for with accompanying letter, and write on check in Memo line with identification. Every unit must have a budget, and income/expenses are balanced. Record all payments in check register, either handwritten in checkbook or Excel or quickbooks. Unit must have backup documentation for audit transparency. An invoice should be attached to reimbursement form. The fiscal year ends October 31, and the county report sent to Melody by November 30. She will send county treasurer an Excel form for report. Each unit files under CCW, Inc., and they have a Tax ID number. Kern and Tehama Counties need to file 90EZ form 110 because more than \$5,000 net in fundraising requires a full tax return.


