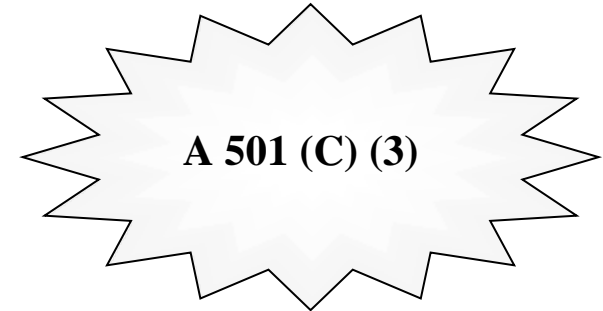

HISTORY

We are an enthusiastic group of women in the agricultural sector. We are women who nurture our families, our communities, and our fertile earth. We are a voluntary group of women with strong commitment, who, late in 2001, assembled, applied for, and were granted 501(c)3 status.

Our CattleWomen spend so much time in classrooms, hosting trips to farms and ranches, donating supplies for the children and the public in their educational efforts, there is little time and energy left for fund raising.

More time spent on education will bring about understanding the need for open space, continued proper grazing, conservation and water quality management. It is most important for the future of our country to develop leaders who communicate well, those concerns within our own industry, in addition to the general public. It is most important that women of ability serve on Natural Resources Boards, Farm Service Agencies, Community Planning Boards, and be available for speaking engagements when called upon.

As stated in our Articles of Incorporation, our Foundation was created to receive grants and charitable donations for the advancement of leadership education and to assist in the promotion of agriculture through education and science.

The Foundation will, in turn, award the funds received, to grantees according to the merits of their proposal or according to the specific request of the donor.
